Score: 3.5 Comments: Students demonstrated strong engagement with the story of redemptive history. The narrative and reflection exhibited a worldview shaped by Scripture. (Note: this criterion may be better assessed under SLO #3 – see below). (2014 Score: 3.5)	Close readings in ENG 3210 Literary Theory and 3320 African American Literature.  Target: Class average of 80%	The average of 9 close reading papers was 3.0. Students scored between 1.5 (unsatisfactory) to 4.0 (excellent).	Students reflect a clear Biblical worldview and are able to articulate the story of redemption in the Bible. There is a clear articulation of the different parts of this story (and as reflected in the Old Testament in particular). The committed noted a few areas that could be developed further in the narrative portion. The duplication of criterion 1 and criterion 3 with SLO 3 was noted, and it may be best to remove these criteria and include this artifact with both SLO 1 and 3.
Criterion 2: Students demonstrate knowledge of key themes they cover in their papers. Score: 3.1 Comments: Students were consistent in their articulation of major events in the storyline of Scripture and the different phases of God's redemptive plan. Some papers omitted significant points, however, such as reference to Jesus' resurrection or the ministry of the prophets in the divided kingdom period, and it may be helpful to highlight themes further as they emerge in various stages of the storyline (2014 Score: 3)

Score: 3.6 Comments: the final projects utilize a variety of exegetical skills and resources. Students completed word studies, genre study, mechanical layouts, historical/cultural/physical research, and contextual study, among other areas, in their projects. Students exhibited clear proficiency in these various areas of hermeneutics. One area of possible development is that of theological analysis in considering the unity and coherence of Scripture (2014 Score: 3)	BIB 3420 Final Project <b>Target:</b> Average score of 3	The final score 3.5	Students receive strong instruction in a variety of areas of theoretical and applied hermeneutics, and the training and practice through the course is evident in the final project. The committee noted few areas of concern in the research and methodology reflected in the project. Further development could be helpful in the E&E statements of some students as well as the exploration concerning the unity and coherence of Scripture. In the case of the E&E statement, it is a matter of students working to develop the ability to synthesize their research and prioritize the most significant elements.
Criterion 2: Students demonstrate solid application of hermeneutical principles in their conclusions. Score: 3.3 Comments: Students applied well the key areas of hermeneutics to the chosen passage as evidenced in the research involved. The E&E statements were of varying depth. Some students provided exemplary descriptions of the text based on their application of hermeneutical principles to the passage, but others needed more development. The inclusion of lesson plans (new to 2017 assessment) will need continued monitoring. Although the students received instruction on Bible teaching in the course, it was brief (in comparison to past instruction in

Students have shown some improvement in the inclusion of Biblical support in the discussion (as per the 2014 program assessment), but more would be beneficial. There was a variety in the quality of the artifacts, and greater scriptural support and concern with practical application would help to raise the overall quality of these assignments. The committee also recommends the inclusion of other artifacts, such as the Progress Narrative Reflection and the exegetical project from Romans, that would help demonstrate this student learning outcome in the Bible major.
Criterion 2: Students articulate the implications of their conclusions. Score: 3.4 Comments: Students reflected well on important aspects of the process of sanctification that impact the Christian life. In the second section of the paper, further articulation of the practical expressions of the sanctification process in the believer's life would help to strengthen this second criterion (2014 Score: 3)

While the total <i>average</i> of scores for this assignment met the goal, 80% of the 9 papers evaluated did not meet the goal of 80%. Three papers scored under 3.0. These three lower scores reflect a number of errors related to content, evidence and reasoning, organization, and expression and literacy. As a result, the average score was 78% for all English majors.
2. Demonstrate the ability to compose a well-written and well-developed literary analysis using both primary and secondary sources.	Research papers in ENG 3310. American Literature: Beginnings to 1865 and ENG 3410 Shakespeare.  Target: Class average of 80%	The average score of 8 research papers was 3.1. Scores ranged from 1.5 (unsatisfactory) to 3.5 (proficient).	This outcome was not met. While the total average of scores for this assignment met the goal, 80% of the 8 papers evaluated did not meet the goal of 80%. One student's score was scored under 3.0 primarily due to lack of secondary support. As a result, the average score was 75% for all English majors.
