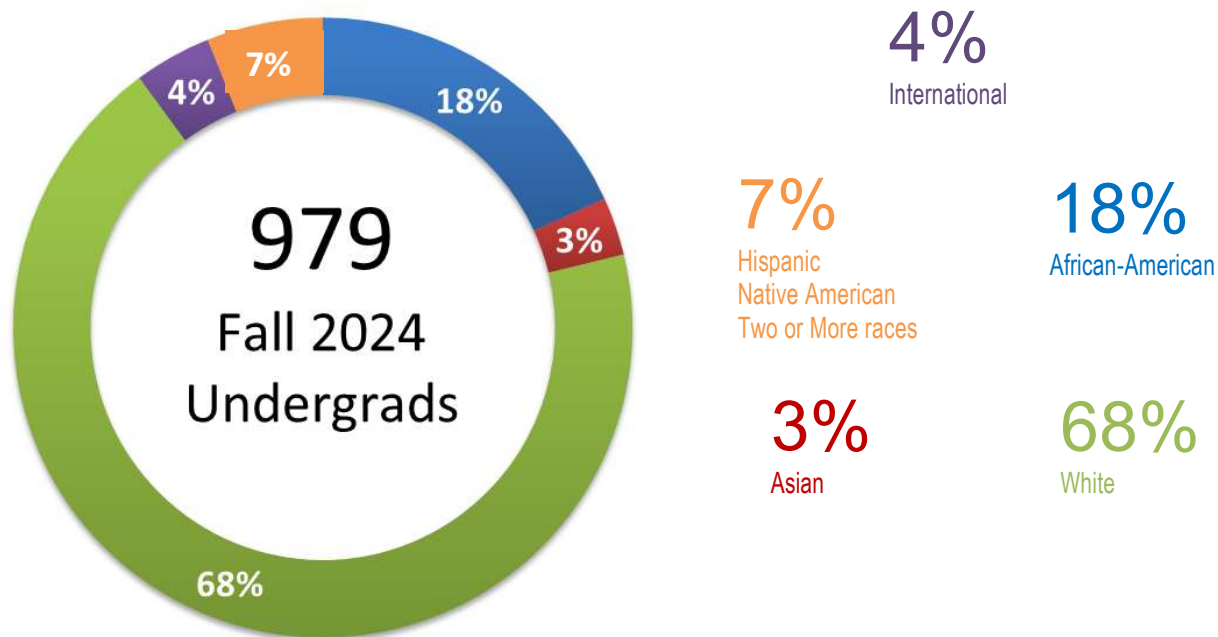

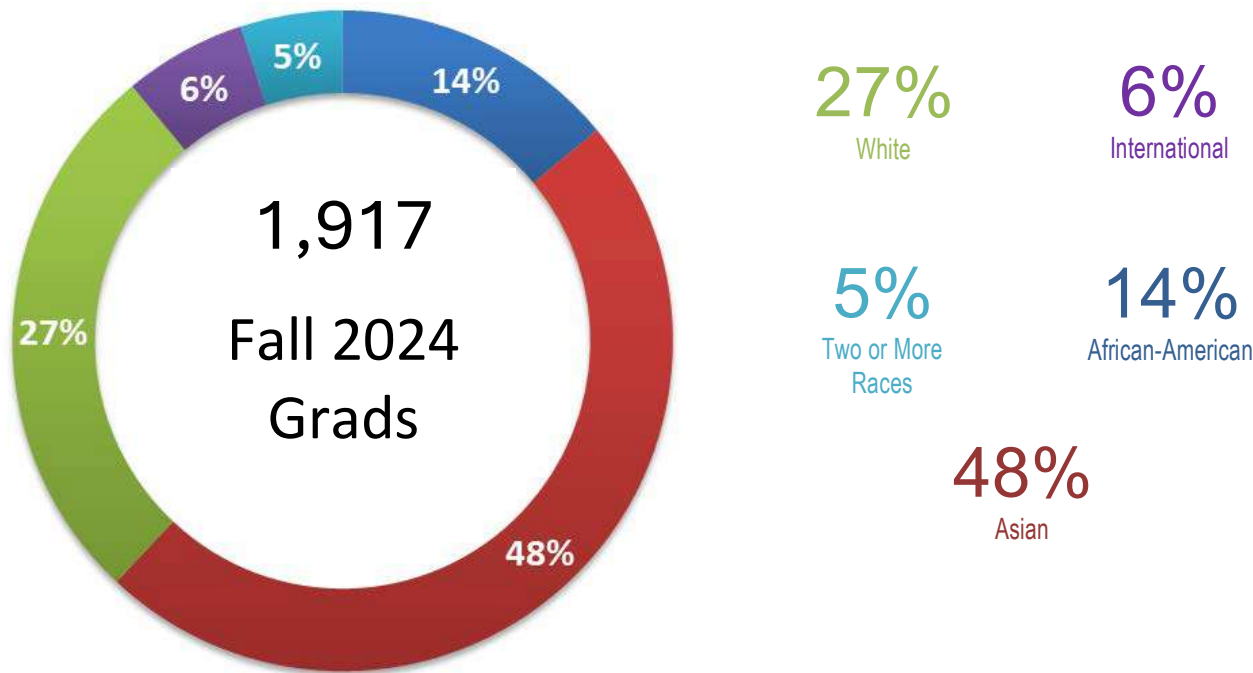

Fall 24 Undergraduate Students by Resident State

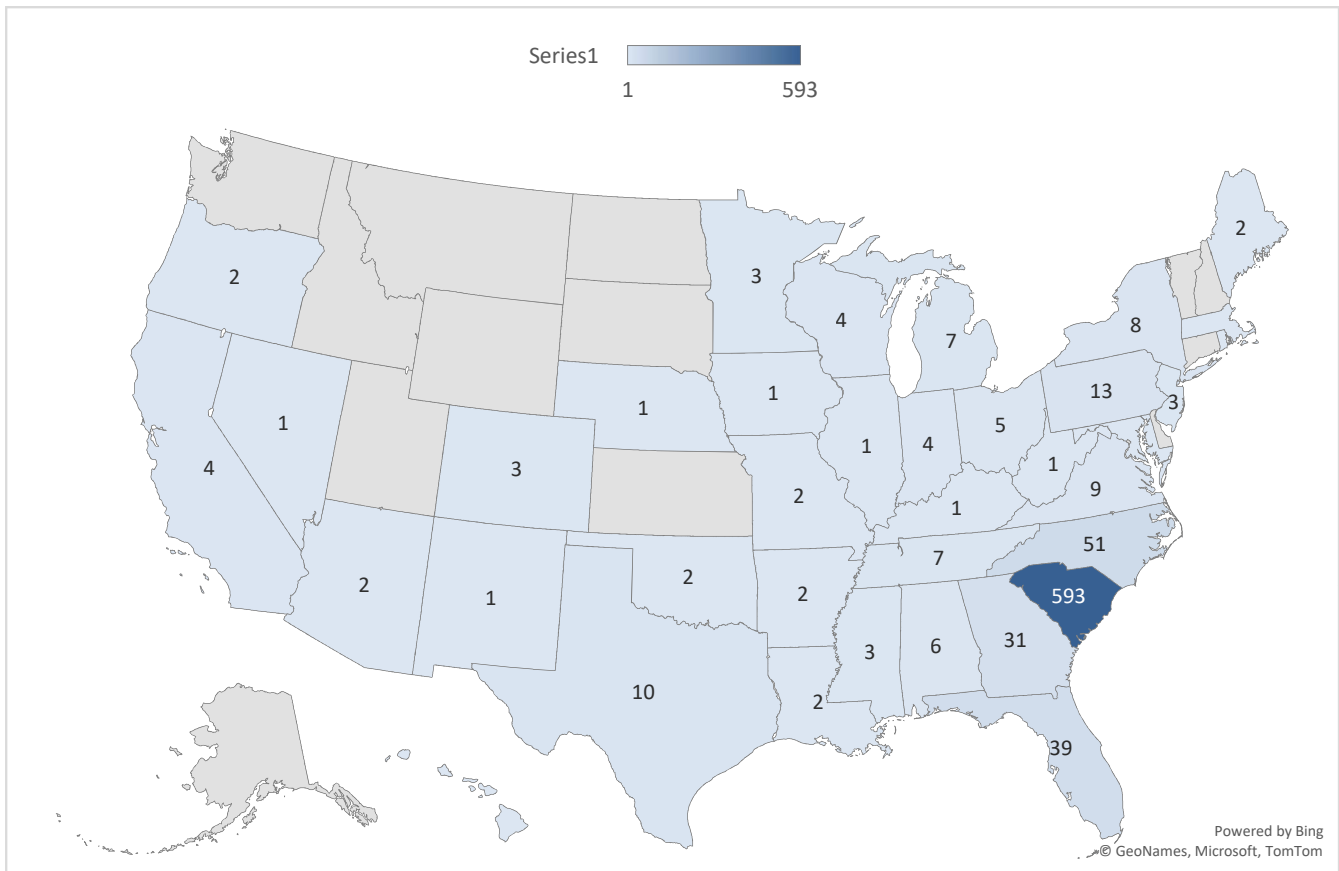

Fall 24 Graduate Students by Resident State

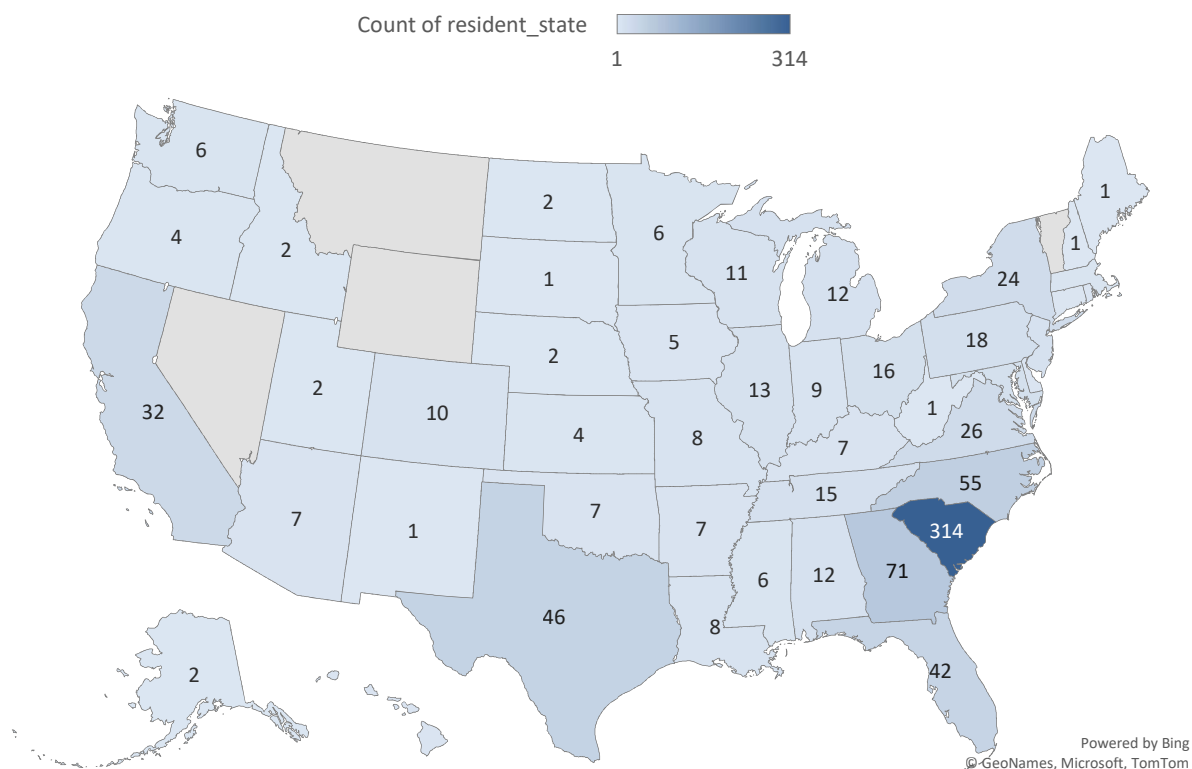

Figure 6-5 – Fall 24 International Students by Country

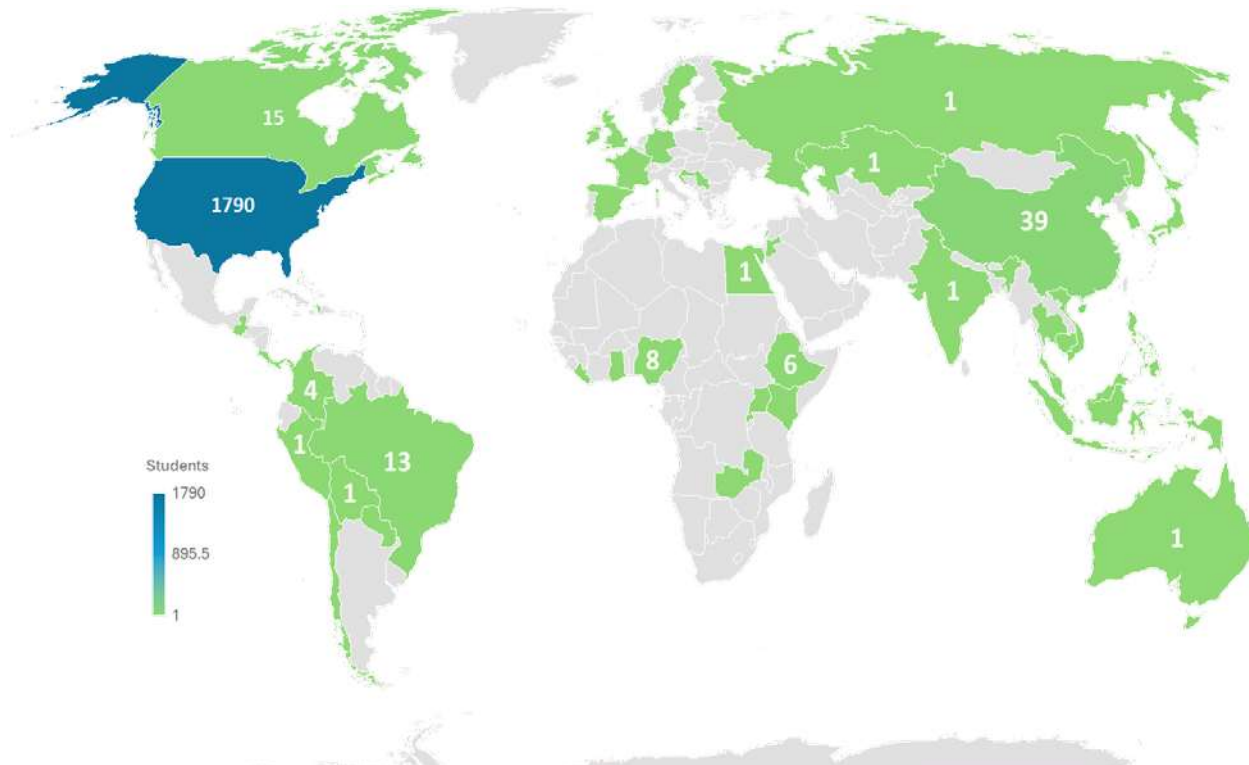
